CENTURY ESTATE FREQUENTLY ASKED QUESTIONS / TERMS & CONDITIONS

Q1. WHERE IS CENTURY ESTATE?

A: CENTURY ESTATE is situated at Oju-Agbe Village, Ibeju Agbe, Lagos.

Q2. WHO ARE THE MARKETING COMPANY OF CENTURY ESTATE?

MILANO PROPERTIES LTD: Leading Real Estate Company in Nigeria

Q3. WHAT TYPE OF TITLE DOES HAVE ON THE LAND?

A: Gazetted by Lagos State Government.

Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A: The land is free from every known government acquisition or interest and adverse claims.

Q5. WHAT IS THE PAYMENT STRUCTURE?

A: (Outright and Installment Payment)

- (a) Outright payment N2,500,000.00 for 600sqm
- (b) 6 Months Scheme N3,000,000.00
- (c) 12 Months N3,500,000.00 for 600sqm
- (e) Commercial plots attract additional 20 % of land cost
- (f) Corner piece plots Attract additional 10 % of land cost
- (g) N.B :-Non-payment of the monthly installments as at when due shall be treated as a fundamental breach of the contract which will result in termination or revocation of the contract/OR attract default charge of 5% of the month payment.

A: 600sqm

A: We give instant plot reservation and allocation

Q7. IS THE ROAD TO THE ESTATE MOTORABLE?

Q8. WHAT OTHER PAYMENTS DO I MAKE APART FROM THE PAYMENT FOR THE LAND?

Q17 WHAT HAPPENS IF I CANNOT CONTINUE WITH THE PAYMENT? CAN I GET A REFUND?

A: Yes, you can apply for refund only if you have not been allocated your plot(s). In the event of a Refund, you are required to give the Company Ninety (90) days' notice to process your refund request and a further Sixty (60) days if the process isn't completed after the first 90 days. The refund shall be processed and paid less 40% (Administrative Fee and Others).
